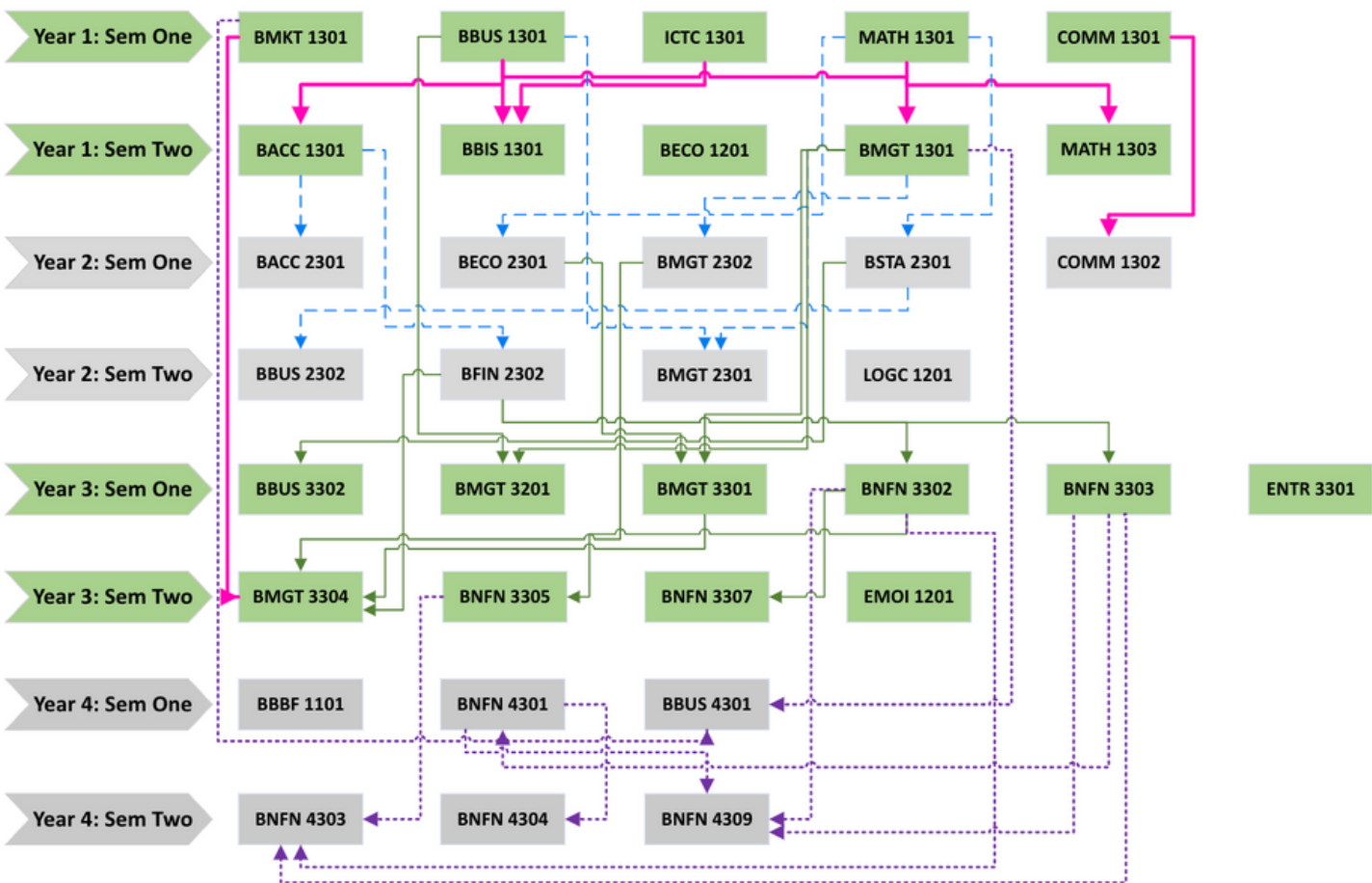

Banking and Finance Program

Course Descriptions

Year 1: Semester One

BBUS 1301: Introduction to Business (3)

Prerequisite(s): None

This course gives an understanding of the aims of business activity and overview of the environment in which business works. All course topics are covered in relation to both the international business environment, in general, and to Saudi business environment, specifically. It outlines major local, regional and international groups within and outside business and their influences on business organizations. It also addresses the different forms of business organizations. The course also covers the main components of a typical business plan.

MATH 1301: College Algebra (3)

Prerequisite(s): None

This course provides a broad-based foundation in algebra which emphasizes important concepts and skills covering the concepts of algebra, such as polynomials, solving equations (linear and nonlinear) and inequalities, and exploring functions and their graphs. Students are introduced to exponential and logarithmic concepts and equations. Real world applications are presented within the course content. Technology is integrated into this course by using a graphing calculator.

BMKT 1301: Principles of Marketing Management (3)

Prerequisite(s): None

This course focuses on marketing principles and the basic marketing decisions facing a firm. It emphasizes the assessment and understanding of the marketplace, marketing strategies, including segmentation, targeting and positioning, product, price, place, and promotional strategies. The course also provides a framework for understanding and implementing these strategies in the local market.

COMM 1301: Communication Skills I (3)

Prerequisite(s): ENRM 1301

This course focuses on the development of intellectual viewpoints, class discussions and debates. The course emphasizes the writing skills needed to produce different types of essays, demonstrating key rhetorical devices and correct citations. It highlights the processes needed for essay development.

ICTC 1301: Information and Communication Technology (3)

Prerequisite(s): None

The course introduces the basic computer knowledge and skills required in the everyday professional and personal use of computers. It focuses on the use of twenty first century technology in the workplace. The course emphasizes computer essentials, word processing, spreadsheets, and presentation software. It further provides a foundation for the use of the Internet, World Wide Web, online communication tools, information security, and latest trends for computers and information.

Course Descriptions

Year 1: Semester Two

BACC 1301: Principles of Financial Accounting (3) **Prerequisite(s): BBUS 1301**

This course provides students with the fundamentals of financial accounting. It explains accounting concepts, theory and procedures for proprietorships, partnerships and corporations. The course covers the accounting cycle as reflected in the sequence of accounting procedures used to record, classify and summarize accounting information in financial reports. All these topics and other advanced topics of financial accounting are discussed in relation to the Saudi business environment.

BMGT 1301: Principles of Management (3) **Prerequisite(s): BBUS 1301**

This course covers the fundamentals of the management process. The basic functions of management: planning, organizing, directing and controlling are covered. Also included are social responsibilities, political influences and ethical considerations as they affect the management of organizations. The course also introduces the students to international business, production, communications and decision making in terms of management activities.

BECO 1201: Principles of Microeconomics (2) **Prerequisite(s): None**

This course introduces the basic economic concepts related to individual decision makers in the economy: households, businesses and governments. It focuses on the definition of economic problems and market systems and addresses factors of production and public expenditures issues. The course analyzes consumer and firm behaviors in different market structures.

MATH 1303: Calculus (3) **Prerequisite(s): MATH 1301**

This course provides an introduction to the use of calculus in some of the basic quantitative methods for business and social sciences. It emphasizes computational skills, ideas, and problem solving. It also introduces the method of least square and regression to model real-life situations and uses the concepts of differentiation and integration in business applications.

BBIS 1301: Business Information Systems (3) **Prerequisite(s): BBUS 1301 + ICTC 1301**

This course provides an overview of information systems (IS) and information technologies (IT) functions and challenges in different organizations and institutions. It presents managerial and organizational views of how information, communication and office technologies function in today's corporate world. It also introduces the technical environment of a business area and the different types of Information Systems used in the various organizational levels.

Course Descriptions

Year 2: Semester One

BACC 2301: Principles of Managerial Accounting (3)

Prerequisite(s): BACC 1301

This course provides an overview of the fundamentals of managerial accounting, with emphasis on the accumulation and usage of cost data. It also covers accounting systems, decision making, cost analysis, budgeting, management evaluation and control.

BECO 2301: Principles of Macroeconomics (3)

Prerequisite(s): MATH 1301

This course introduces macroeconomic analysis related to economic relationships. It covers national income accounting and determination, business cycles, aggregate demand, aggregate supply, inflation, unemployment, fiscal and monetary policies, money and banking, economic growth and development, and international trade. It focuses on the characteristics of the Saudi business environment in business operations.

BMGT 2302: Human Resource Management (2)

Prerequisite(s): BMGT 1301

This course introduces the field of human resources management and its main functions. It also familiarizes the students with the strategic role of human resources management in achieving organizations competitive advantage. The emphasis is on the main success measures for human resource activities, job analysis and design, recruitment and selection, performance and evaluation management, training and development, and career planning.

BSTA 2301: Statistics for Business (3)

Prerequisite(s): MATH 1301

This course aims at providing the necessary tools to analyze statistical information critically. It introduces concrete examples handling data sets and using standard techniques for displaying, summarizing and analyzing data. The course also covers business applications using statistical inference and hypothesis testing techniques for business problem-solving and decision-making.

COMM 1302: Communication Skills II (3)

Prerequisite(s): COMM 1301

This course reinforces critical reading and academic texts analysis. It focuses on advanced writing skills towards the development of different types of essays using APA style. The course emphasizes writing an extended argumentative essay.

Course Descriptions

Year 2: Semester Two

BBUS 2302: Quantitative Analysis for Management (3)

Prerequisite(s): BSTA 2301

This course provides an overview of operations research/ management science methods and their role in decision-making. The emphasis is on problem formulation and managerial interpretation. The course further emphasizes how managers can use this approach to design and control business processes to increase profitability and decrease costs for the organization. It also introduces quantitative procedures through situations that include both problem formulation and technique application integrated with personal computer software.

BFIN 2302: Financial Management (3)

Prerequisite(s): BACC 1301

This course introduces the basic theories, concepts and analytical techniques in Financial Management. It focuses on goals, objectives and functions of the financial manager as well as analysis of financial statements. It emphasizes on financial assets valuation and making long term investments and financing decisions particularly decisions related capital structure and capital budgeting. All topics are discussed with reference to the Saudi Market

BMGT 2301: Principles of Organizational Behavior (3) Prerequisite(s): BBUS 1301 + BMGT 1301

This course focuses on understanding human behavior in organizational settings. It emphasizes the causes and consequences of human behavior in organizations. It covers the effects of the organizational structure on the individual, the reward and leadership process, and the impact of managerial effectiveness on the organization. The course also provides a framework for understanding and implementing management functions involved in strategic planning and programming.

LOGC 1201: Logic and Problem Solving (2)

Prerequisite(s): None

This course introduces fundamentals of logic and techniques to enhance the skills of problem solving. It covers the properties of number system, methods of reasoning and set operations, counting and probability. It focuses on basic elements of logic with emphasis on constructing truth tables for different statements to produce logical conclusions.

Course Descriptions

Year 3: Semester One

BMGT 3301: International Business Management (3) Prerequisite(s): BMGT 1301 + BECO 2301

This course focuses on the nature and scope of international business and introduces the three environments in which international business managers must operate. It also provides an understanding of domestic, international, and foreign environments. It addresses the concepts of international business in local market conditions.

BMGT 3201: Legal Environment of Business (2) Prerequisite(s): BBUS 1301 + BMGT 1301

The course provides essential information concerning the legal environment in which businesses operate. It introduces legal concepts that affect business activities with emphasis on legal reasoning and problem-solving skills that can be applied in a business context. All the aspects of law covered in this course are examined from both international and Saudi law perspectives.

BNFN 3303: Investment Analysis and Portfolio Management (3) Prerequisite(s): BFIN 2302

This course focuses on the skills and competencies necessary for understanding, analyzing and applying the concepts and theories of investment in the Business environment. It provides an understanding of the return generating process of assets, including stocks and bonds. In addition, it details how various assets can be combined in efficient portfolios within the mean variance framework.

BNFN 3302: Commercial Bank Management (3) Prerequisite(s): BFIN 2302

This course introduces the management theory and practice relevant to banking institutions. It focuses on the analysis of commercial banks' financial statements and performance. It assesses the asset liability management strategies applied in commercial banks. It also evaluates the management strategies of different uses and sources of funds in commercial banks. The course emphasizes on the Saudi Commercial Banking practices and laws.

BBUS 3302: Research Methodology (3) Prerequisite(s): BSTA 2301

This course provides an overview of the nature of business and management research. It introduces the fundamental tools of research methodology. It also includes training in the areas of primary and secondary data collection and qualitative and quantitative methods of organizing data and utilization of research findings.

ENTR 3301: Entrepreneurship and Design Thinking (3) Prerequisite(s): None

This course introduces the concept of entrepreneurship, nature of enterprise and role of the entrepreneur. It emphasizes the theoretical and practical perspectives of the entrepreneurship process. The course also explores other aspects of entrepreneurship including the development and evaluation of business plans and the presentation and pitching to the business investors.

Course Descriptions

Year 3: Semester Two

BMGT 3304: Strategic Management (3) Prerequisite(s): BMGT 2302 + BMGT 3301 + BFIN 2302 + BMKT 1301

This course provides an overview of strategic management concepts and theories, and their importance to the organization, industry and society. It covers the analyses, decisions and actions an organization undertakes in order to create and sustain competitive advantage. It presents an insight into the successful operation of an organization in a complex global economy. This course addresses these operational issues in the Saudi business environment.

BNFN 3305: Risk Management of Financial Markets and Prerequisite(s): BNFN 3302 Institutions (3)

This course provides an understanding of the process of financial intermediation. It describes the role of financial institutions and financial markets in the process of capital formation in the economy. It also provides a deep understanding of how to identify, measure and manage risks in financial institutions. The focus is on interest rate risk, market risk, credit risk, foreign exchange risk and liquidity risks. The courses centers around the Saudi business environment.

BNFN 3307: Islamic Banking and Finance (3) Prerequisite(s): BNFN 3302

This course aims to introduce the main principles of Islamic banking and finance. It analyzes the difference between Islamic and conventional banking models. This course additionally focuses on major Islamic products and services offered by Islamic banks, economics of profit sharing, operations of Islamic banking, and operations of Islamic insurance. All topics are discussed in relation to the Saudi business environment.

EMOI 1201: Emotional Intelligence (2) Prerequisite(s): None

This course focuses on the key concepts of Emotional Intelligence. It emphasizes the importance and benefits of Emotional Intelligence. It also raises awareness about the role of competencies and skills in an individual's career.

Course Descriptions

Year 4: Semester One

BBUS 4301: Business Ethics and Social Responsibility (3) Prerequisite(s): **BMGT 1301 + BMKT 1301**

This course introduces ethical issues and dilemmas which arise in business contexts. It provides ethical concepts and frameworks that are relevant to resolving business problems. The course covers moral principles in business, ethical dilemmas and issues facing individuals and organizations, and safeguards to maintain ethics in business.

BNFN 4301: Corporate Finance (3) Prerequisite(s): **BNFN 3303**

This course discusses the goals of the financial manager and presents the analytical methods and practices of modern financial management. It addresses in more depth, various financial management topics and issues. Major finance concepts and theories are presented together with their applications. All these topics are discussed in relation to the Saudi business environment.

BBBF 1101: Basic Body and Brain Fitness (1) Prerequisite(s): **None**

Course Descriptions

Year 4: Semester Two

BNFN 4309: Investment Banking (3) Prerequisite(s): BNFN 3302 + BNFN 3303 + BNFN 4301

This course introduces the concepts and scope of investment banking. It focuses on the primary functions of investment banking such as mergers and acquisitions (M&A), IPO, leveraged buyouts (LBO) and corporate restructuring and the different valuation methods. It also covers ethical issues and the regulatory framework of investment banking.

BNFN 4304: Financial Policy (3) Prerequisite(s): BNFN 4301

This course introduces the application of the concepts, skills, tools and techniques acquired in finance and other business courses to real finance problems. The course focuses on setting appropriate financial strategies and policies. It mainly utilizes the case method of instruction. Prerequisites: BFN 4301 Corporate Finance.

BNFN 4303: Internship: Banking and Finance (3) Prerequisite(s): BNFN 3302 + BNFN 3303 + BNFN 3305

This course provides the opportunity to gain knowledge through actual job experience in the profession. Internships represent job experience which is aimed at supplementing the classroom learning process and to allow familiarization with real world experiences related to the Banking and Finance profession. The internship program period covers 180 hours of working experience applied at a bank or a related financial institution locally or internationally.
