The Dawning of a New Era

The Beginning

Dar Al-Hekma University was first established in September 1999 as a college built to serve the educational needs of young ambitious women in the community who sought quality education and challenging careers in pioneering fields. It is a premier non-profit institution of higher education for women in Saudi Arabia and a leading model of teaching and learning institution, nationally and internationally. A pioneering project of the Al-Ilm Foundation, Dar Al-Hekma was built with the objective of providing state of the art higher educational facilities and services through academic institutions, such as colleges and universities, in the Kingdom of Saudi Arabia.

After nearly four years of intensive planning and successful implementation, Dar Al-Hekma University, still a college then, garnered 120 candidates in its first year. Enrollees poured into three different majors: Management Information Systems, Interior Design and Special Education.

Dar Al-Hekma began facility expansion in 2003, with financial support from Mohamed Bin Issa Al-Jaber, a Saudi businessman, for whom one of the buildings was named. Applications for enrollment in 2003 exceeded Dar Al-Hekma's number of graduates, a development corresponding with the Kingdom's realization of high female unemployment at the time.

The academic programs at the college were developed by the Texas International Education Consortium (TIEC), Austin, Texas as part of the larger contract to design the complete blue-print for the various divisions of the college. For developing the academic programs, TIEC appointed project element teams with Saudi and international experts and academics who were charged to develop the curriculum. About 140 experts were recruited to serve on the various project elements teams to complete the task of developing the overall curriculum, the detailed course description and course syllabus as well as information on the laboratory component and text books, etc. The work of the teams and the program

documents they produced were reviewed and approved by the Academic Committee appointed by the Founding Committee and the final program was submitted for approval to the Ministry of Higher Education, which assured national accreditation. The standards used for developing the curriculum closely followed the requirements of the Middle States Association in the United States, which will further facilitate international accreditation.

In addition to its master's programs, Dar Al-Hekma University currently offers four-year bachelor's degree programs in six majors with up to 142 credit hours and a liberal arts component comprising a variety of general education courses. To this day, Dar Al-Hekma continues to uphold its promise of being a creative and supportive learning community, retaining its commitment to the liberal arts, whilst preparing graduates for professional success.



The Metamorphosis

Since the summer of 2008 Dar Al-Hekma began its pursuit of university status. The quest was a long and vigorous journey; but the college's swift and steady increase in its student population, year-in and year-out, was the predominant incentive in its plans to rapidly grow the infrastructure from a single building to a multi-building campus. This multi-building campus would house conference-halls, auditoriums, a separate building for the Design Program and a countless of other facilities such as a race-track, gymnasium, swimming-pool, etc.

Since the inception in 1999, and excellence was, and still, is Dar Al-Hekma's main goal. To achieve this goal, the university developed four pillars of excellence: teaching, learning, operational, and strategic excellence. These principles are to be accomplished through the university's 18 strategic objectives it developed which need to be achieved over yearly objectives from the different university departments. The objective behind Dar Al-Hekma University's strategy is to graduate future generations that exhibit independent learning, analytical and critical thinking, and high level of culture that is based on research and exploration, distinctive ability in problem solving with a creative look on community service.

On January 16, 2014 Dar Al-Hekma was honored with the decision of being awarded the university status with the consent of the Custodian of the Two Holy Mosques King Abdullah bin Abdulaziz; and with the continuous support and encouragement from the Minister of Higher Education, Dr. Khalid Al-Angari.

On Sunday, January 26, Dar Al-Hekma not only started its second semester but also celebrated the new status as a university. During the celebration, students, faculty and staff sang their hearts out. Everyone was so cheerful and ecstatic to be part of a university now. The celebration ended with the sound of the university anthem and everyone singing along as they headed back to class.

To mark this memorable moment of becoming a university, Dar Al-Hekma University are set to have another celebration in the near future and will invite everyone who was part of this journey since the beginning. "My gratitude goes to the Custodian of the Two Holy Mosques King Abdullah bin Abdulaziz for his wise order. Also I would like to thank the Minister of Higher Education, the Honorable Dr. Khalid Al-Angari, on everything he made possible for the university and higher education in general," said Dr. Suhair Hassan Al-Qurashi, the President of Dar Al-Hekma.

Dar Al-Hekma University joins hands with Babson College

Often linked to daring innovation calculated risk-taking, entrepreneurship entails taking the initiative to develop, organize and manage a business venture (along with the risks) with the aim of making profit. Under the patronage of HRH Prince Mohammed bin Nawaf bin Abdul Aziz Al-Saud, the Ambassador of the Kingdom of Saudi Arabia to the United Kingdom and Ireland, and in the presence of the Minister of Higher Education Dr. Khaled Al-Anqari, Dar Al-Hekma University participated for the first time in the Saudi Job Fair.

The Saudi Job Fair was hosted in London, on the 30th and 31st of March 2013. The job fair was designed to provide Saudi graduates and final-year students with an opportunity to meet with senior representatives from leading companies and institutions in Saudi Arabia who were looking to recruit talented and motivated youth. Dar Al-Hekma University President Dr. Suhair Al-Qurashi was among the honored quests at the ceremony.

Dar Al-Hekma University was among the 62 organizations that took part in the job fair. With the goal of aligning purpose, people and values, the university partook in the fair to meet the brightest Saudi students face-to-face, and consequently recruit exceedingly qualified high-caliber individuals.

Dar Al-Hekma's booth featured promotional brochures highlighting job-offers and its MBA and Undergraduate programs. Dar Al-Hekma post-cards and copies of Noor Al-Hekma Magazine were distributed, and the booth included a plasma-screen with a slideshow of images of campus Life and the graduation video.

Five representatives from the university manned the Dar Al-Hekma booth during the course of the two-day event, including graduates Lama Sahab, Samah Al-Safadi and Dr. Sanaa Askool who interacted with visitors, talking about their experiences and education at Dar Al-Hekma University.

Overall, the career fair was a wonderful opportunity for the graduates to network within a short period of time. Dar Al-Hekma was able to both establish new contacts with academic and business organizations, as well as screen potential candidates.

Many students voiced their optimism at the employment prospects presented to them at the career fair. Over the two-day event, the job fair managed to attract more than 2000 visitors and Dar Al-Hekma managed to collect 110 CV's (of which 30 were male applicants). 7 candidates were later contacted for interviews and one of them recently joined the Dar Al-Hekma community as a teaching assistant in the Architecture program.

Participating in the Saudi Job Fair was part of Dar Al-Hekma's ongoing efforts in favor of the recruitment, retention, training, development and capability of Saudis in various disciplines and roles. The job fair was very successful and it is Dar Al-Hekma's intention to participate in next year's fair, in support of the King's vision

of reducing unemployment and focusing on job opportunities for women and ensuring the university's success by fostering Saudi Arabian economic development and social prosperity.

One-on-one with Dr. Amal Al-Yamani

Dar Al-Hekma Program Director of Special Education, Dr. Amal Al-Yamani, believes that all children, especially those with special needs, have the right to be given equal opportunities to reach their full potential. As such, the Special Education Program at Dar Al-Hekma University prepares aspiring special education teachers with the skills and tools needed to identify the characteristics of different types of learners, and to improve the quality of life of children with special needs, bringing about necessary changes in society at large.

Noor Al-Hekma Magazine recently spoke with Dr. Amal, to learn more about the Special Education Program and the tools it provides to students who are passionate about educating and caring for all students - no matter their individual gifts, abilities, or needs

1. Please tell us a bit about yourself, your qualifications and your achievements.

My name is Amal Ali Al-Yamani, a mother of 3 (Lina who is 15, Ahmad 12 and Omar 4). I graduated from Umm Al-Qura University with a degree in Social Studies and then received my master's degree in Special Education from Boston University.

I then joined the clinical psychology program and got a masters and doctorate from Argus University in Atlanta, USA, with a specialization in family and childhood. I am interested in the fields of practical measurement, diagnosis and early intervention.

After receiving my master's degree and while working on my PhD, I worked in several centers in the United States in the field of diagnosis and treatment for children with special needs - especially children with autism disorders.

2. What is the Department of Special Education?

The Special Education Department was established in 1999 in Dar Al-Hekma University. The department aims to help improve and raise the standard of living for children with special needs and their families through qualified and skilled

professionals.

The Special Education Department is made up of two active specializations: autism and learning difficulties.

3. What is the future vision for the department?

Thanks to the Almighty, we have graduated 137 girls so far, but our vision is greater than that, and we aim to attract a larger number of students and to provide more direct services to the community.

4. What are the requirements to enroll in the Special Education Department?

Conditions that apply to the department are the same as university enrollment requirements. In addition, of course, the desire to work with children, especially those with special needs.

Therefore, whoever is interested and willing to help others, loves children and has a bubbly personality would excel in this major. Dar Al-Hekma also asks students to take personality tests that will help them choose majors that fit their tendencies and interests.

5. What positions will the graduates hold and what responsibilities will they have?

It is a large field and it's up to the graduate depending on her interests and ambitions. The aim is to graduate skilled and qualified students to work in public and private schools and centers within the community. I also advise my girls to never set limits for their future career ambitions!

Facts on Autism

A major problem for people with a learning disability is that other people don't understand what it means for someone to have a learning disability" (Calderstones Partnership NHS Foundation Trust, n.d.)

Some graduates are content with their bachelor's degree and want to work with the degree obtained, and there are definitely many opportunities out there for them. On the other hand, other graduates want to continue their education and apply for master's degree and PhD, and prefer to specialize in more than one field. The community needs everyone.

Some graduates work in private and public schools, private centers and institutions that serve children with special needs and there are some other graduates who have gone abroad to continue their higher education in the same or similar field.

6. In your opinion, what do you think are the biggest problems and obstacles you face as the director of the Special Education Department in Dar Al-Hekma?

One of the biggest challenges the department faces is the number of enrollments. Only a few girls apply, which may be due to lack of awareness within the community about the majors offered as well as the career development after graduation.

7. To what extent do you think the Saudi job market needs qualified and skilled professionals in the field of Special Education?

As I mentioned before, it is a big field and the need for qualified and experienced professionals to work with children with special needs in private and public schools and centers is growing.

8. What do you feel when working with children with special needs?

Teaching is a noble profession and I don't think anyone would disagree, as well as the important and psychological impact it has especially when performed with sincerity. Not to forget the great feeling you experience when you've made a change and helped a child and a family; you've contributing in transforming a vulnerable group into a group of active and productive individuals who will help in shaping the community in the future.

9. What activities were carried out by the Department of Special Education during Special Children's Day?

Every year, the department organizes several activities that are meant to enhance the skills and personality of students; as well as contribute to the community service and strengthen the sense of social responsibility, and to provide training and education in order to raise the level of efficiency in teachers of special education in the community.

And one of the activities done once a year by the Department of Special Education is the celebration of the International Special Children's Day. During this event, schools and community centers are invited to take part is a special workshop that aims to teach the strategies of special education teachings. Among the activities done by the Department of Special Education during the International Special Children's Day in Dar Al-Hekma, is hosting several centers specialized in children with special needs in Jeddah. And as mentioned earlier, the celebration event serves several goals such as showing the organizational skills and talents of the students as well as their passion and knowledge with children evident in their activities performed with the children.

The event also gives the students the opportunity to work with a group of people that owns a special place in our hearts. All of this has a positive impact on all of us, whether on the centers or the children who attend the event, it strengthens our senses towards social responsibility and we get a feeling of fulfillment when we see the smiles on the children's faces.

10. Do you think it is important to deal with autistic children at an early stage?

I believe early intervention is a very important factor in improving symptoms in the future and to control the nature of the disorder. Early diagnosis and treatment must be our top priority as they impact both individuals and society's future.

11. What advice do you give the parents of children with special needs?

You have a major and important role in creating a positive change in the lives of your children and in the community, Insha'Allah (Godwilling).

12. What message would you like to give to those interested in joining the Special Education Department?

The major is fantastic. There are a number of diverse areas you can work in and society really needs those specializations. Your society needs you!

- No meaningful, two-word phrases (not including imitating or repeating) by 24 months


Taking A Leap Into Oceans Of Knowledge, Advancing A Nation Dar Al-Hekma's Research Center

"As research tool, the internet is invaluable 'Noam Chomsky

Dar Al-Hekma University's Research Center was established in September 2012 by Dr. Maryam Ficociello – a Dar Al-Hekma alumna and one of the university's first graduates in 2003. She received her MA and PhD degrees from the London School of Economics and has worked as an Assistant Professor in the Management Information Systems Program at Dar Al-Hekma University.

Dr. Ficociello has extensive experience in a major IT research project with the National Health Services (NHS) in the UK – results of which were published in the British Medical Journal – and won the 'Best Paper Award' for her first publication at the American Conference on Information Systems (ACIS) 2012 during her post-doctoral fellowship.

While the Research Center has only been in operation for a little over a year, it has certainly come a long way. In this interview, Dr. Ficociello shares the center's developments with Noor Al-Hekma Magazine.



1. Why was the Research Center established?

Since the center's initiation in September 2012, Dar Al-Hekma was supposed to be a teaching college, i.e. simply teach students and offer them degrees. Over the year, we felt that we wanted to move towards a university model. Of course, a teaching college is very different from a university - one of the biggest differences is the research component, therefore we established the Research Center.

2. How many people work with you right now?

We have a full-time research office and a faculty research committee of 7 members, their role is also advisory. We also have an external advisory committee underway. In addition, we have created a system to review 20 different projects and registered about 9 projects.

3. What services / facilities does the Research Center offer?

It's not a Research Center with just one focus, it's the research arm of the university. The whole idea is to encourage ethical, productive and skilled investigators among staff, students, and faculty. We try to promote research throughout Dar Al-Hekma University, make connections with other places around the world that are doing research and we're establishing policies at the moment related to research.

We're responsible for everything related to encouraging and facilitating student and faculty research. We ensure that our students take the appropriate measures when conducting research and participating in research. On a faculty level, we make sure it is part of their evaluation that they participate and publish research

just like in any other university. And finally, we make sure we connect with the community in Jeddah and that our research has a good impact on it, by finding out what problems exist in the community and conducting research to find solutions to these problems.

So it's not a center in the typical sense, though it's called one, but it really should become, later on in the future, the Deanship of Research. In Saudi Arabia, they typically combine research with post-graduate studies, so it may be combined into graduate studies and become a Deanship of Research and Graduate Studies.

4.Do you incentivize the faculty and students to do research?

Yes, that is part of our mission: to incentivize faculty, staff, and students to conduct research.

The incentives we now have in place for faculty are part of our promotion policy. As a university, we didn't need to have a full-fledged promotion policy having faculty move from Assistant Professor to Associate Professor and finally to Professor. But as we become a university, we need that structure in place. And the biggest determinant for promotion in academia is research. Teaching is an important component, but research is really what makes it or breaks it.

We like to say we're transitioning ourselves from a teaching institution to a teaching-research institution. We cannot just move from teaching to research, it would take us 10 years to do that.

We're also gradually making it part of faculty evaluation. So this year, for example, research constituted 5% of their performance evaluation. Next year, it will be 10%, the year after 15%, and so on. Research in big universities should be 60% of faculty's performance evaluation; imagine how important it is, but this is for a purely research institution. For students, one of our biggest initiatives is policies. We didn't have an intellectual property rights policy, now we have one.

We don't have anything on research

ethics, now we're working on that policy. We're also working with the graduates to have a research handbook as we discovered that it might be useful for students as well. And we're reviewing the curriculum across Dar Al-Hekma. We have a little taskforce that is looking up all the curricula in Dar Al-Hekma for things such as how many times students get mentorship for research

So we're trying to make people more aware and embed it into our culture. The awareness efforts are for our faculty, staff, and students.

5. Are the students required to do research as part of the fulfillment of their degree?

They don't have to do a graduation thesis/dissertation in all programs. So, for example, in the MIS system, they build a practical system that they write a report on, but it's not research. There's a lot of data gathering for requirements analysis but it isn't publishable research.

I can't say that there's one single program that has a dissertation component involved in it. unfortunately, which is maybe something that we need to look into. In my view of the world, I would like that to become a major piece of it all - that they have graduation dissertations. It could work for two of our schools: the School of Business and Law I can't see how it would work too well for the School of Design and Architecture because their work is mostly practical, but even they need to be very aware of ethical issues and intellectual property rights because for the arts community it's even stricter.

6. What have been the major achievements of the center so far?

We're still building up the structure of the center, but we have increased the participation in the Fourth National Saudi Scientific Conference from one participant last year to 26 this year on the student level. On the faculty level, we've built research transitional plans that incorporate incentives for faculty to conduct and participate in research. We've also built policies to encourage the

faculty to do more research. These are the main achievements that have been on every level of the institution. It is the first time in Dar Al-Hekma's history that we have applied for 3 different grants from King Abdullah University of Science and Technology (KAUST) and they're all collaborative: internal, national and international. In total, they come to a sum of about 2 million Saudi Riyals. This will result in job creation for students and graduates as research assistants.

7. How does the Research Center reflect on the quality of education at Dar Al-Hekma?

The drive is behind quality education because without research we would become outdated. It is important that the faculties are always updating their own knowledge through research. It is vital for our ranking as a research institution.

We are aiming to increase Dar Al-Hekma affiliated publications over the next 5 years that are indexed in the web of science/knowledge as this is the only way to receive international recognition. Research is not only important for the quality of education, it also raises the standards of our faculty and students, which will also help us attract high caliber faculty and students and better employers for our students.

Dar Al-Hekma's Student Support Center: One of a Kind

The Dar Al-Hekma Student Support Center provides a range of unique services available to all students for free. Students may receive confidential services ensuring that they get professional top-notch assistance in both their psychological and academic development. The Student Support Center recognizes students as individuals with different needs, aiming to provide specialist services to enhance student experience and to support them throughout their studies. The Student Support Center is divided into two main support areas:

1. Counseling & Career Services

The Counseling & Career Services Department is managed by Dar Al-Hekma Consultant Dr. Fouzia Ashmackh. Prior to joining Dar Al-Hekma University, Dr. Fouzia Ashmackhwas an Assistant Professor at King Abdulaziz University. It has always been Dr. Fouzia Ashmackh's personal mission to educate people on the importance of professional assessment to understand what the best major and career is for each individual. She continuously visits schools on her own and gives frequent lectures on the importance of professional interests. She also has a clinic where she provides family counseling.

In 1998, Dr. Fouzia joined Dar Al-Hekma University as a part-time counselor. She interviews, tests, and evaluates job applicants to guide them into choosing the most suitable career. The process in evaluating each individual is psycho-technical. During the employment process, Dr. Fouzia recognized that many employees studied majors that they did not want because they were placed there from the university.

As the department manager, Dr. Fouzia has developed policies and procedures for the career and,= counseling development department.

She realized that students were not selecting their majors for the right reasons. Instead, they chose majors based on influence from friends, family, and society which is not the ideal way to choose a major.

In 1999, a program was initiated where students were assessed to help them figure out the most suitable major for them. However, only highly-motivated and concerned students took the test. She would speak to CPP (College Preparation Program) students about the importance of the assessment; however, not all students were proactive. Within 5 years of implementing the program, admissions realized that many students that did not take the professional assessment test ended up switching majors later. Students who changed majors were upset and demotivated due to lost time and money.

In 2005, it became a requirement for all students to meet with Dr. Fouzia for a systematic assessment before choosing a major. Each student would take a personality assessment test before sitting with Dr. Fouzia to discuss her history and interests.

Based on different variables following the analysis, each student is given 3 recommendations for majors. After the implementation of this program, Dar Al-Hekma University admissions noticed a drop in the percentage of students changing majors or dropping out. It was not until recently that other universities began to see the importance of professional assessment in selecting a major and career path. Fortunately, many universities are in the process of

providing similar services to their students.

2. Academic Support Center

Dar Al-Hekma University's Academic Support Center is the only center in the Kingdom which has become an integral part of the educational experience, in combination with the institution's existing career advising and counseling services. It offers its services to any student that faces any learning difficulty and helps her identify her learning style and succeed accordingly.

The center is directed by Dr. Rasha Mashmoushi, an educational psychologist who has completed her Masters and PhD, as well as trained in the UK. She has also acquired further experience in Dubai in both educational institutions and clinical

setting before joining Dar Al-Hekma.

People with learning disabilities are largely undiagnosed, commonly marginalized, and greatly misunderstood. With the necessary support and timely intervention, all this can change. The primary trigger for this change has to come from us – we need to be informed, have an understanding, as well as provide those with learning disabilities with equal opportunities.

Dar Al-Hekma University's upper management was aware that students with learning difficulties were not getting the necessary support, as they were being taught using the same methods as students without any learning difficulties. Therefore, Dar Al-Hekma introduced the Academic Support Service to provide students, with learning difficulties, with an equally fruitful educational experience. The center involves every student that faces any learning difficulty when taking a course and tries to accommodate their challenge.

It is not very easy to identify a student with a learning disability. As such, Dr. Rasha follows a process that can be summed up as follows:

- 1. Identify the student with learning difficulties through referral (instructor, program director or staff)
- 2. Some students don't really have a learning difficulty and just need to

Hajj in the Year 1908

"They will come to you on foot and on every lean camel, coming from every remote path" – Surat Al-Hajj (22:27)

Visitors to Dar Al-Hekma University were given the chance to witness how Egyptian pilgrims experienced and performed Hajj in the year 1908 - a period long before Saudi Arabia was even conceived. Titled 'Pilgrimage to Makkah 1908', a four-

day photography exhibition, held from September 29 to October 3, showcased the entire Hajj journey from Egypt. Dar Al-Hekma organized the exhibition in cooperation with Al-Turath Foundation and the French Consulate General in Jeddah. The photographs document the 1908

(1325 Hijri) pilgrimage that began in Egypt, ending all the way in Makkah and Madinah. The collection was found in the Dominican Institute for Oriental Studies (IDEO) archives in Paris and is the original work of Dr. Muhammad Al-Husayni, a Muslim photographer who worked in Jeddah's British Consulate. His collection, comprising 53 images, was on display with captions and

History

The pilgrimage to Mecca has been going on since pre-Islamic times, as Makkah's economic prosperity during the time of the Prophet Muhammad (PBUH) was largely due to the income from visitors.

Muslims believe that the steps of the Hajj correlate to the story of Hajer, the second wife of Prophet Ibrahim whom he married after Sarah was childless. After Ibrahim (PBUH) left her and her infant son, Prophet Ismail (PBUH), in the desert, she frantically ran between the hills of Safa and Marwa to look for food and water for her baby after their provisions ran out.

As she prayed to Allah for mercy, Ismail's heel hit the ground and the well of Zam-Zam sprang forth to nourish them. When Ibrahim (PBUH) returned, he built the Ka'abah with the Ismail's help.

portrayed the different stages that pilgrims had to go through during their trip. Examples of a few scenes captured on camera were pilgrims boarding ships, pilgrims arriving in Makkah and riding on camels as means of transportation to reach the holy sites. The pictures also show a number of officers who were in charge of the Western region, Hijaz, prior to the unification of the Kingdom in 1932.

Two lectures were offered on different days of the exhibition: "Hajj and the Universal Order" and "Prophetic Monuments in Hijaz and Makkah".

"As part of our efforts to preserve Saudi heritage in all forms, we supported the 'Pilgrimage to Makkah 1908' exhibition, in with the cooperation of the French General Consulate, particularly Dr. Louis Blin the Consul General of France," said Dr. Osamah Al-Gohari, Director of the Al-Turath non-profit foundation.

He added, "53 pictures we provided for the exhibition are a rare documentation of the Hajj and serve as an opportunity for researchers to study."

Aside from the photographs documenting the 1908 Hajj journey, an additional 50 paintings were displayed at the exhibition to shed light on the Holy Ka'abah throughout the ages, before its great expansion.

Dar Al-Hekma University shows great interest in the arts and has a long history of supporting and encouraging art exhibitions and programs, both nationally and internationally. "It is such a pleasure to be a part of this experience and to be able to facilitate the opportunity for women in my country to enjoy these historic heartwarming photographs," said Dr. Suhair Al-Qurashi, President of Dar Al-Hekma University.

"Ever since childhood days, I've always dreamt of meeting an astronaut," said Hind AlSahtout, a student of Management Information Systems. And who would have thought that one day her dream would actually become reality at Dar Al-Hekma University when two female astronauts - Linda Godwin from USA and Korea's first astronaut Yi So-yeon – visited the Dar Al-Hekma and shared awe-inspiring experiences of space exploration, confinement in a shuttle and life above the stratosphere.

Astronauts Linda Godwin and Yi So-yeon, along with 100 others from 18 countries, were in the Kingdom to participate in the Second International Space and Aeronautics Technology Conference 2012 in Rivadh to discuss latest developments and research in space and aeronautics technologies, particularly those of major interest to Saudi Arabia. Space and aeronautics systems and technologies have become a fundamental part of the Kingdom's economic, scientific and national security competences.

"We feel totally removed from our normal cycle, lacking the sense of time as we sometimes rotate the earth over 15 times a day," said Godwin describing her life in the space shuttle during her talk at Dar Al-Hekma's auditorium. Linda also talked about the "rumbly" take offs that are "not as violent as a roller coaster." And she warned the girls about "space hair," and, "It's probably best to be bald," she joked.

Female astronauts inspire students at Dar Al-Hekma

'It was emotional to see Earth from such a far distance'

Dr. Linda Godwin is not just an astronaut but also a scientist who has accomplished several important space missions. As a child, Linda was interested in math and science. "I grew up watching a lot of the early U. S. space programs," she said. These programs fueled Linda's interest in science as well as her classroom science teachers who kept her fascinated and curious. When Linda was in college, majoring in physics and math, she started thinking about becoming an astronaut. She researched about the degrees she would need to get into the NASA program. She completed a Master of Science degree in 1976 and a PhD in physics in 1980. She then went to join NASA in 1980 and became an astronaut in 1986.

On the other hand, Dr. Yi Soyeon never really wanted to be an

astronaut. It all came to her as a matter of chance when she was selected from among 36,000 applicants to serve as her nation's first astronaut. According to her, this was rather a national than personal accomplishment. She is treated as a celebrity in her homeland. She has a master's degree in mechanical engineering and a PhD in biological science. She currently serves as a senior researcher at the Korean Aerospace Research Institute and as an adjunct professor at the Korea Advances Institute of Science and Technology (KAIST) where she lectures on space experiments, bio-systems and human space flight. She wrote a book. "The 11th Endeavor: The First Astronaut in Korea, Yi So-veon's Full Story," which was published in August 2012.

"Every mission has a lot of learning involved. It was so emotional to see the Earth for the first time from such a far distance," said Yi who made history by becoming the first South Korean astronaut to travel into space. Only two other countries (Iran and the UK) have had a woman as their first space explorer.

The enthusiastic students of Dar Al-Hekma, joined by students from Dar Al-Fikr School were released early to attend this fascinating and universal event, and they asked many questions after the astronauts' presentation.

Attendees learned about the training process, space exploration, life in a space shuttle, and the challenge of being selected to a male-dominated team of astronauts. The girls also learned about the importance of looking ahead, aiming high and taking risks.

The students loved every part of the event and consider themselves lucky to have had the opportunity to meet with 2 of the world's 500 astronauts. "I'm very fortunate to be studying at an institution where people of success and high ambitions come to share their life journeys and great achievements," said Hind.

Dar Al-Hekma regularly organizes such events as part of its mission to enhance creativity, excellence, intellect and independent thinking among its students. And this event in particular was to motivate the girls to achieve excellence in science, mathematics and engineering, fields meant to be mainly for men.

"Don't think of yourselves as women. You are not women. You are people. Don't victimize yourself. The fact that I'm a woman is my greatest advantage, because it makes me work so much harder. Even when I know I am being discriminated against, I try not to think of myself that way, work harder and work the situation to my advantage," is Yi's message to all the women out there.

Hekayat Ashara Photography Exhibition





On a cool December evening, Park Hyatt witnessed a great rush of people headed towards its Sohba Garden. This time, it was not to attend a wedding, nor to get an unrivalled view of the Red Sea or the beautiful leddah fountain, but to marvel at the photographs taken by 10 extraordinary women from the Al-Ruwais District at the "Hekayat 10" photography exhibition.

The "Hekayat 10" photography project is a Dar Al-Hekma University community service initiative dedicated to empowering ten selected women living in Al-Ruwais District by giving them the power of expression through the mastery of the art of photography. This project was very unique and had caught the interest of Dr. Suhair Al-Qurashi, President of Dar Al-Hekma University, that she awarded the "Hekayat 10" project as the "Most Innovative CS Project in Dar Al-Hekma's History".

Though the "Hekayat 10" women were of different nationalities (4 Saudis, 3 Somalis, 2 Yemenis and one Filipino), they shared one common thing - their residential district, Al-Ruwais. It is considered to be one of the oldest areas in Jeddah, dating back to over 300 years ago. The streets of that district represent 3 centuries of Jeddawi history, heritage and culture.

During the opening of the "Hekayat 10" exhibition, the photographer with the best collection was announced and honored. Ms. Ashwag Al-Muallad, a Dar Al-Hekma employee, was the lucky winner and won the 1st prize of SR 10,000 for the best photograph.

The two-day exhibition was a remarkable success. It showcased a collection of 40 photographs, 4 from each participant, featuring and documenting the different areas and historical parts of Al-Ruwais. "The Story of 10" is a project that came to life through Ms. Zaynab Odunsi, a passionate photographer and a lecturer at Dar Al-Hekma University. The project involved over 40 participants from various departments such as Graphic Design, Interior Design, Architecture, Continuing Education and the CS Office.

Dar Al-Hekma University President Dr. Suhair Al-Qurashi stated, "Through the project, and with the support and guidance of 10 of our students from Hekma School of Design and Architecture, 10 women that live in Al-Ruwais were given the chance to uncover their own potential and talent in mastering the art of photography and use it to their advantage."

Ms. Zaynab Odunsi, founder of the "Hekayat 10" photography project, is a photography teacher and lecturer at Dar Al-Hekma. She described the

project as an interactive mission to involve less fortunate women and focus on their capabilities through teaching them the art of photography.

I came up with the idea of the project after a trip with some of my students to distribute food and toys to some communities in Al-Ruwais and other districts. I thought it would be nicer to do something with long lasting results that benefit a wider society as part of the college's commitment to service the community," said Ms. Odunsi.

This project was incepted less than a year ago and had taken a life of its own. The next logical step was to organize a photography exhibition and a great exhibition it was indeed!

Ms. Roua Basaad, the buddy captain, was still a student when Ms. Odunsi told her about the idea of the project, explaining what she had in mind, sparking Ms. Basaad's interest with three words: culture, documentary, and empowerment. She described the project as a rewarding and challenging experience which allowed her to

grow personally and academically.

"Being involved from the onset of the project allowed me to see many sides of the "Hekayat 10" project, getting a piece from every cake! Observing the evolution of the project closely; from ideas on sticky notes, sketches on paper to an actual fully developed project, and best of all watching how the 10 women progressed week after week, their enthusiasm, and eagerness was the fuel to our energy as they pushed us on even on those rare dark days," said Ms. Basaad who was a graduate by the time the project started.

Ahaad Al-Amoudi, another buddy, learned a lot from this experience, "We have been involved in this project for almost one year, working alongside one another. The beauty of the project stems from the opportunity it allowed us in being a part of a community initiative that gave these women a chance to learn and expand their horizons. Working on a project that gave back on a one-to-one level and a community as a whole is extremely inspiring,"

Moreover, Dr. Lamya Gazzaz, Vice Dean of Student Affairs, described the project as a "rewarding experience in which Dar Al Hekma students took on the role of mentors to 10 remarkable ladies from Al-Ruwais District, teaching and assisting them on how to master the art of photography." She added, "As a result, inspiring pictures were captured and a collection of images from Al-Ruwais District will remain in the Hekayat Ashara book as a reference for future generations."

"Hekayat 10" was created with passion to empower women, as well as to engage the community. At the same time, the ladies of the "Hekayat 10" project are encouraging the younger Saudi generation to care more about their community and heritage by portraying the beauty of their surroundings.

Samar Al-Ammari, a college student and one of the Hekayat 10 participants said, "I had a camera in my hand six years ago, and I was the family photographer just because I loved photography. I wanted to take this hobby to the next level, but was not sure how.

As a Saudi, I feel proud to have participated in this project. It enabled me to link between my hobby of six years and my life and memories in Al-Ruwais. I was born and raised in Al-Ruwais, and once behind the camera, I saw things I never noticed before - the beauty in the streets I pass by every day. The project brought a great change in my life and my family's life. Initially, it was challenging for me to engage with people from other nationalities, but now I feel like I can do many things to make my people and my country proud. Photography has always been a dream to me, but now I can say I can dream, and for that I am so lucky. Zaynab has been a good mentor and has inspired us to believe we can do anything we set our heart and minds to do."

When the ceremony finally came to a close, Dr. Suhair thanked everyone who made the event a success and said, "My sincere gratitude to all sponsors, participants and audiences that made this event a reality. Let this project be the start of other community service projects and let "The Story of 10" be the beginning of many new stories that are waiting to be told!"


and the interactive skit.

My participation in the Pearl Initiative Student Case Study Competition was definitely one of those profound eye-opening experiences and I feel incredibly fortunate to have been a part of it.

Eight months, three weeks, six days, nineteen hours and seven minutes ago. . . if anyone had asked me to define the term 'corporate governance', I probably would have shrugged and said something along the lines of "Oh, isn't that what happens after a coup d'état?".

Developed in cooperation with the United Nations Office for Partnerships, The Pearl Initiative is the leading independent, non-profit, by-business for-business, institution working across the Gulf Region of the Middle East to positively influence and improve corporate accountability and transparency.

I was in the second semester of my senior year at University when our Faculty Champion, Dr. Maryam Ficociello, told us about the casestudy opportunity. I, along with my two team-mates, Yasmin Moosa and Nada Rashid, immediately went online to find out what it was all about. What we read really inspired us to join the competition. as the Pearl Initiative aspiration is to improve transparency and accountability among businesses in the Arab world. The Pearl Initiative experience reinforced what we learned from Dar Al-Hekma University - to always act with integrity, honor and truthfulness.

Participating in this competition was, especially for us as University students, quite frightening to say the least. The concept of corporate governance and accountability and transparency were all very new to us and was not something frequently encountered in academic conversations and class discussions in Saudi Arabia. Nonetheless, we took it as a challenge. It was like being introduced to a whole new world - it felt refreshing to discover all these ideas that the three of us were now suddenly privy to.

Deciding on a target company for our case-study was possibly one of the toughest parts of the contest. However, having one of the best mentors that anyone could ever ask for on your side really helps, and my team-mates and I were lucky to have Dr. Maryam Ficociello guiding us as Faculty Champion. Out of all the businesses on our list, we found that Dr. Soliman Fakeeh Hospital (DSFH) had one inspiring story to tell about their quest for transparency. Right then, like sweet serendipity, we knew we had found the jackpot. It was a story that just had to be shared and announced to the world!

During our study, we were astounded by the tremendous effort we discovered that DSFH actually puts into ensuring that sound corporate governance procedures are in place. The hospital's commitment to Corporate Social Responsibility (CSR) began as early as 2008 by forming a CSR team. From

that point on, DSFH moved swift and determined with perseverance. Simply put, DSFH is the paragon of Corporate Social Responsibility reporting and transparency in the Kingdom and we were elated to have found them as our target company.

It is known that almost every law student craves the chance to one day get to practice their legal skills, defend clients and make certain that justice is served. The 3rd Vis Middle-East Pre-Moot, held in Abu Dhabi this past 2013, provided Dar Al-Hekma University's very own law students with an excellent platform to live out their dream whilst competing against other law students who hail from six different Arab universities in Iraq, Jordan, Oman, Tunis, the UAE and Bahrain.

The Vis Moot is a legal competition for law students worldwide on the topic of international commercial law and arbitration. It is held annually in Vienna, attracting over 300 law schools from all over the world. The first Moot was held in 1994 with 11 law schools from 9 countries. By 2011, the Moot had expanded to 254 teams from 63 countries.

The Pre-Moot Competition takes place before the actual Vis Moot and brings together a number of schools to participate in sessions that provide Vis competitors the opportunity to practice the presentation of their arguments. Typical pre-moots round up about 4 to 12 schools to practice their arguments.

Al-Hekma University's participation in Abu Dhabi's Pre-Moot Competition could not have come at a more perfect time, as it was during this period that Saudi women were finally granted licenses to practice law. Months ahead of boarding a plane to Abu Dhabi, the students dedicated hours of prep-time to studying and researching the case provided, writing memorandums, and going through rigorous preparations.

Asmaa Al-Bakri, Badriya Modir, Daliya Sayed, Fatima Al-Kuhlani, Layan Al-Khouli, Noor, Zahran, Reem Zahid, Sarah Abu Taleb, and Yasmeen Al-Kathiri of the Legal Department all put in tremendous effort that eventually led to their marvelous victory. After having gone to Abu Dhabi and experienced an intensive three-day training session, the Dar Al-Hekma delegation pleaded against four other teams in the general rounds. 2013 that is held every January in Davos-Klosters, Switzerland. She was among the panelist in "The Arab Context" session along with H.R.H Prince Turki Al Faisal, Chairman of King Faisal Center for Research and Islamic Studies, H.E. Mr. Kamal Bin Ahmed Mohammed. speaker at the 4th United Nations Forum on "Minority Rights", in Geneva, Switzerland. Dina is also the Founder and the first President of the Dar Al-Hekma University Alumnae Association. Additionally, she is the first Saudi female to act as an International Observer at Presidential Elections in some Organization of Islamic Cooperation (OIC) since April 2010 and introduced the "Go Green" project at the OIC headquarters in Jeddah.

Dina is a member of the Global Shapers Program, an initiative called to life by the Word Economic Forum. This program was launched in 2011 and includes highly motivated and extraordinary individuals in their twenties who have great

leadership potential that they want to take advantage of to serve their society. Global Shapers are organized into local Hubs based in over 180 cities worldwide and are engaged in projects that aim to improve their cities. The Jeddah Global Shapers Hub, for example, is currently working to sustain the fishery profession in the Western Region through providing creative solutions and implementing sustainable projects for the benefit of the fishermen community of Rabigh. On the international level, Global Shapers make sure the voice of 50% of the world's population under the age of 27 is heard within all of the Forum's activities. 
Seven years later, Ms. Batterjee was bestowed the 2013 Employer Achievement Award.

Interview with Dr. Lamya Gazzaz

Vice Dean of Student Affairs

Student learning doesn't just happen in a classroom nor does student experience solely rely on academic programs offered. Opportunities for learning and development exist everywhere and anytime on campus and it is the Student Affairs responsibility to seize these moments. The Student Affairs Department at Dar Al-Hekma University plays an important role in providing the students with a pleasant experience through a comprehensive, creative and caring approach that supports and empowers the students socially, emotionally and mentally.

And the Students Affair would not be the Students Affair Department if it wasn't for Dr. Lamya Gazzaz's hard work, commitment and dedication. Dr. Lamya has been with Dar Al-Hekma for over 10 years and has gradually built the department nearly from scratch to become a one-of-a-kind leading program across the Kingdom

And in light of Dr. Lamva's retirement plan, we took the opportunity to meet up with her for an interview for Noor Al-Hekma and below is what she had to say to us.

Hello Dr. Lamya, we heard that you will be retiring soon from Dar Al-Hekma. But before you leave us we would like to take this opportunity to ask you a few questions for the Noor Al-Hekma Magazine.

1. Before we start with a few questions, would you kindly introduce yourself to our readers, talk a bit about yourself; who is Dr. Lamya, what did you study and how did you join Dar Al-Hekma

Well, I was born in Taif, grew up in Makkah and lived my life in Jeddah at a time when young women had limited career opportunities and could only choose between teaching or medicine. I didn't like the idea of becoming a teacher then, how ironic it seems now, so I decided to join the Medical Program in KAU in 1979 instead. After two years of going through human anatomy and medical sciences, I discovered that it wasn't something I saw myself

doing all my life so I decided to switch to the College of Nursing & Allied Sciences with the support of Dr. Suhad Bahijri, who was then Vice Dean of College of Medicine and Allied Health Sciences at KAU. She also counseled me before switching major; I thoroughly enjoyed studying nursing and in 1984 I received my BS in Nursing.

After my graduation, I joined the National Guard Hospital as a diabetic nurse before being sent to the UK to do a Post Graduate Diploma in Health Education in Developing Countries then a master's degree at Leeds Metropolitan University. Pursuing my master degree was actually postponed for a year

in 1990-1991 and I had to work with UK-MoD team to train National Guard soldiers on First Aid and Managing War Casualties. Once the war was over, I went back to Leeds and picked up where I had left off and finally received my MS in Health Education and Health Promotion in 1993. With my Masters in hand, I established the first nurse-managed diabetic clinic at the National Guard Hospital. I was also able to initiate other health education programs "Maternal Child Health" and "Management of Chronic Disease" at NG Primary Healthcare Centers. I stayed with the National Guard Hospital for a total of 10 years. In 1994, I was one of few who were selected to work at Abdul Latif Jameel Rehabilitation Center, a

center that deals with victims of road traffic accidents and other patients who are in dire need of rehabilitation and therapy. This experience was unique because everyone of the initial team worked together to plan the strategies/ services/structure of the center. While representing ALI in a conference in Eastern Region, I met with a group of Quality Improvement from Aramco who eventually offered me a job with Aramco's Medical Designated Facilities Department in Jeddah. Under the umbrella of this huge department, I was one of few nursing representatives responsible for monitoring and overseeing the network of contracted hospital facilities of Aramco across the country. While with Aramco, I climbed the ladder of success and

got promoted on a regular basis and one other step towards promotion was the move to the Eastern Province where I reached a fateful crucial decision that I won't be able to live away from my mother and the rest of my family even for a promising career path. Shortly after returning to Jeddah, I received an offer to work at Dar Al-Hekma; the offer was prepared by Dr. Suhair Al-Ourashi and Ms. Fatma Bayoumi. In September 2000. I started working as a lecturer in Dar Al-Hekma. I did realize that it was a complete career change, switching from healthcare to academia but it was a challenge I happily accepted so here I am still 13 year later. Dar Al-Hekma was a small community when I first joined, all the students, faculty and staff knew one another and we used to meet

up for lunch with the Dean. It was the "golden age". A year later I was part of the division of Student



After having worked with Dar Al-Hekma University for a year, I was appointed as Acting Vice Dean of Student Affairs between 2001-2002. Since I couldn't become a Vice Dean without a PhD, I decided to pursue my studies and I went once again to the U.K to get the degree. In 2009 and with a PhD in hand I returned to my second home Dar Al-Hekma where I got promoted to Vice Dean.



3. Dr. Lamya, in your opinion what do you think makes Dar Al-Hekma so unique. What are the opportunities that are found only at Dar Al-Hekma?

Amongst all educational institutions for women, Dar Al-Hekma provides the best extra-curricular activities in KSA and we have even shared the extra-curriculum plan with other institutions. n addition, Dar Al-Hekma is the first college in KSA to have a Student Government Body with a constitution, which was given to the Ministry of Higher Education as Social Responsibility on DAH part. The Student Development program focuses on 5 dimensions: intellectual (e.g. Toastmasters & MUN Club, etc); physical (e.g. sports activities like basketball and table-tennis); spiritual (e.g. Dar Al-Ouraan & the LIFE 'Let Islam Fulfill Everyone' Club); self-development (e.g. students' employment wherein students may work a maximum of 10 hours per week); and social & psychological (e.g. community service scheme & leadership training). All co-curricular activities promote these dimensions with the purpose of building holistic individuals with well-rounded personalities. Our students are also required to perform 100 hours of community service before they graduate. We also provide Career Advising, Counseling and Academic Support services. Dar Al-Hekma is a great institution and I'm proud to be part of its progression.

4. What were your best and most memorable moments in Dar Al-Hekma?

The most memorable time for me was the graduation ceremony of the first batch. It was like seeing my own daughters graduate or get married. I taught them all and I was so very proud of them and extremely happy to see them standing there wearing the academic robes and hats. A lot of emotions were involved. After all,

it was at a time when we all knew each other- a big happy family that is witnessing the growing up of its daughters who are leaving their nest.

5. Why did you decide to retire now? How did you know that this was the right time?

I have achieved a lot at a professional level, both in healthcare and academia, and I had a fruitful and outstanding career. I was really blessed in my career and life but there comes a time when one needs time for oneself and for the family. My mother is the most important person in my life and I have decided that it is her time now. I want to dedicate my time in taking care of her and myself. I enjoy reading, exercising and travelling and now is my chance to sit back, relax and enjoy the blessings in life and do the things I never got the chance to really do.

6. Last but not least, do you want to give your students any advice on their way?

It is not enough to have ambitions; you must work hard to achieve your goals. I want to remind them that education and learning is a lifelong experience. Take it seriously, enjoy it and grab every opportunity. There is no harm in working hard for four years; it is like growing a fruit – watch yourself grow and flourish- so enjoy every minute of it. I also highly recommend that you get some work experience before continuing your higher education to get a clear idea of what you want to do in your career.

And please do come back to Dar Al-Hekma after graduating, it is always nice to see graduates return to work or participate in events like the career fair. Keep in touch with Dar Al-Hekma, we are one family and do keep in touch with me for I would love to hear from you once in a while and see what you are doing.
